An Act amending title 18 Virgin Islands Code, chapter 3, section 41 regarding Boards of Election to establish a single board of elections

PROPOSED BY: Senators Kenneth L. Gittens, Kurt Vialet and Justin Harrigan ,Sr.,

1 Be it enacted by the Legislature of the Virgin Islands:

2 SECTION 1. Title 18 Virgin Islands Code, chapter 3, section 41 is amended in the following

3 instances:

4 (a) The title is amended to read: "Board of Elections".

5 (b) Subsection (a) is amended by striking all of the language in the subsection and 6 inserting new language that reads as follows: "There is a single board of elections that governs both 7 election districts."

8 (c) Subsection (b) is amended by striking all of the language in the subsection and 9 inserting new language that reads as follows: "The Board consists of fourteen members; seven from 10 each district, who are elected by the electors of each election district beginning with the 2018 general

1	election. No more than four members of the same political party may represent a district, including	
2	individuals who are not affiliated with any political party."	
3	(d)	Subsection (c) is amended by:
4		(1) striking "1986" and inserting "2018";
