1 Be it enacted by the Legislature of the Virgin Islands:

2 SECTION 1. Pursuant to Title 3 Virgin Islands Code, chapter 25, subchapter VII, 3 section 633, the Legislature of the Virgin Islands ratifies and approves the First Renewal 4 Agreement for Group Medical Health Insurance dated September 30, 2014, between the 5 Government of the Virgin Islands through the Health Insurance Board of Trustees, the Virgin Islands Port Authority, the University of the Virgin Islands, the Virgin Islands Housing 6 7 Authority, the St. Thomas East End Medical Center Corporation, Non-Profit Organizations 8 defined as eligible by the Government under the First Renewal Agreement and Frederiksted Health Care, Inc., and Cigna Health and Life Insurance Company, "CIGNA", which is attached 9 to and made part of this Act as Appendix A. 10

SECTION 2. Pursuant to title 3 Virgin Islands Code, chapter 25, subchapter VIII, 1 2 section 633, the Legislature of the Virgin Islands ratifies and approves the Third Renewal of the Group Dental Health Insurance Agreement dated September 30, 2014, between the Government 3 of the Virgin Islands through the Health Insurance Board of Trustees, the Virgin Islands Port 4 5 Authority, the University of the Virgin Islands, the Virgin Islands Housing Authority, the St. Thomas East End Medical Center Corporation, Non-Profit Organizations defined as eligible by 6 7 the Government under the Third Agreement and Frederiksted Health Care, Inc., and "CIGNA" 8 Health and Life Insurance Company, which is attached to and made a part of this Act as 9 Appendix B.

SECTION 3. Pursuant to title 3 Virgin Islands Code, chapter 25, subchapter VIII, 10 section 633, the Legislature of the Virgin Islands ratifies and approves the Third Renewal of the 11 12 Group Life and Accidental Death and Dismemberment Insurance Agreement dated September 13 30, 2014, between the Government of the Virgin Islands through the Health Insurance Board of Trustees, the Virgin Islands Port Authority, the University of the Virgin Islands, the Virgin 14 Islands Housing Authority, the St. Thomas East End Medical Center Corporation, Non-Profit 15 Organizations defined as eligible by the Government under the Third Agreement and 16 Frederiksted Health Care, Inc., and "AETNA Life Insurance Company, which is attached to and 17 made a part of this Act as Appendix C. 18

Section 1 of the bill approves the Medical Health Insurance Agreement between the
government and CIGNA. Section 2 approves the Third Renewal of the Group Dental Health
Insurance Agreement between the Government and Cigna. Section 3 approves the Third
Renewal of the Group Life and Accidental Death and Dismemberment Insurance Agreement.
