An Act providing appropriations for operating expenses of the Supreme Court of the Virgin Islands, the Superior Court of the Virgin Islands, the Judicial Council and the Office of the Public Defender and amending title 4 Virgin Islands Code, chapter 2 relating to the administration of the Judiciary

Be it enacted by the Legislature of the Virgin Islands:

- **SECTION 1.** The sum of \$1,498,742 is appropriated from the General in the fiscal year ending September 30, 2008, to the Supreme Court of the Virgin Islands for operating expenses.
- **SECTION 2.** The sum of \$26,574,378 is appropriated from the General Fund in the fiscal year ending September 30, 2008, to the Superior Court of the Virgin Islands for operating expenses.
- **SECTION 3.** The sum of \$300,000 is appropriated from the General Fund for the fiscal year ending September 30, 2008, to the Judicial Council of the Virgin Islands for operating expenses.
- **SECTION 4.** The sum of f \$3,000,000 is appropriated from the General Fund for the fiscal year ending September 30, 2008, to the Office of the Public Defender for operating expenses.
- **SECTION 5.** Title 4 Virgin Islands Code, section 31, subsection (d) is amended in the following instances:
 - (a) In paragraph (1), strike the language "courts in this regard" and - insert "Supreme Court":
 - (b) In paragraph (2), strike the word "courts" where it first appears and insert "Supreme Court".
 - Strike the language in paragraph (3) in its entirety and insert the -following:

"The Chief Justice has general oversight of the judicial branch of the Government of the Virgin Islands. Nothing in this chapter may be construed to authorize the Chief Justice to exercise control over the day-to-day administrative operations of the Superior Court of the Virgin Islands, including the Magistrate Division.";

- (d) In paragraph (4)(A), after the word "judiciary" insert "including the report for the Superior Court prepared by the Presiding Judge of the Superior Court" and after the word "budget" insert "for the Supreme Court, which must include the annual budget for the Superior Court prepared by the Presiding Judge of the Superior Court";
- (e) In paragraph (4)(B), insert at the end of the first sentence the following phrase, "including transfers and schedules submitted by the Presiding Judge of the Superior Court for consolidation by the Supreme Court"; and
- -(f) Strike the language in paragraph (5) in its entirety and insert the -following: -

"The powers entrusted to the Presiding Judge of the Superior Court pursuant to 4 V.I.C. §§72b, 79, 86, 91, 92, 351, 411, 412 and other provision of the Virgin Islands code remain in effect as they pertain to the Superior Court."

SECTION 6. Title 4 Virgin Islands Code strike §34, subsection (b) in its entirety—and renumber the remaining subsection accordingly."

- (b) In paragraph (2), strike the word "courts" where it first appears and insert "Supreme Court";
 - (c) Strike the language in paragraph (3) in its entirety and insert the following:

"The Chief Justice has general oversight of the judicial branch of the Government of the Virgin Islands. Nothing in this chapter may be construed to authorize the Chief Justice to exercise control over the day-to-day administrative operations of the Superior Court of the Virgin Islands, including the Magistrate Division.";


