EXECUTIVE ORDER NO. 470-2014

**TO SET THE DATE FOR PAYMENT, THE DATE OF DELINQUENCY, AND THE
DATE FOR APPEAL FOR THE 2013 RESIDENTIAL AND COMMERCIAL REAL
PROPERTY TAX BILLS**

By the authority vested in me as Governor by the Revised Organic Act of 1954, as amended, and the laws of the United States Virgin Islands, it is hereby ordered as follows:

Section 1. Policy

- a. It is the policy of the United States Virgin Islands that the Tax Assessor, pursuant to Virgin Islands Code, Title 33, Section 2494, shall send notices of the new due dates for payment of property taxes.
- b. It is the policy of the United States Virgin Islands that the Tax Assessor shall prepare and determine the **2013 Real Property Tax Bill for Residential and Commercial Properties**, which were not able to be issued to real property owners within the time prescribed by law.
- c. It is the policy of the United States Virgin Islands, that when the ordinary time for issuance allotted under the Virgin Islands Code lapses or is delayed, Virgin Islands Code, Title 33, Section 2494, authorizes the Governor, through Executed Order, to extend the time for payment, the date of delinquency, and the date for the appeal, in order to afford equitable treatment for taxpayers receiving delayed assessments.

Section 2. Dates for Payment of Real Property Taxes

- a. All **2013 Real Property Tax Bills** shall be due and payable on or before **Monday, October 6, 2014**.


- b. All 2013 Real Property Tax Bills shall be delinquent if not paid before **Saturday, December 6, 2014.**

Section 3. Date for Filing of Appeal of Real Property Tax Bill


- a. The last day for filing an appeal for the 2013 Real Property Taxes Bills shall be **Tuesday, December, 23, 2014.**
